**NOTICE OF PROPOSALS**

**North Norfolk District Council HEREBY GIVES NOTICE** in accordance with regulation 7 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended) (**the Regulations**) of its intention to make an Order under its powers contained in Sections 32 and 35(1) and (3) of the Road Traffic Regulation Act 1984 (as amended) (**the Act**) the effect of which will be:

1. To amend the relevant provisions of the North Norfolk District Council (Off-Street Parking Places) Order 2022 (**the Principal Order**) which applies to all off-street car parks operated by the Council.
2. The variations include, and are applicable to the off-street car parks, as follows:
3. To update the Principal Order to increase the tariff charges for the Pay and Display parking at the Parking Place identified as 'Holt Country Park Car Park' in Holt to which the Principal Order applies.

The Variation Order may be examined at the Council Offices, Holt Road, Cromer, Norfolk, NR27 9EN between the hours of 9.00 am and 5.00 pm Monday to Friday or accessed online on the Council's website.

Any objection or other representation relating to the proposed variations should be made in writing. All objections must specify the grounds on which they are made. Objections and other representations should be sent, marked for the attention of the Asset Management Officer, at the address given above by 4<sup>th</sup> October 2024.

North Norfolk District Council (**the Council**) in exercise of its powers under Sections 32, 33, 35, 35C and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (**the Act**), as amended, and all other enabling powers, with the consent of the Norfolk County Council in accordance with Section 39(2) of the Act and after consulting with the Chief Officer of Police in accordance with paragraph 20 of Schedule 9 to the 1984 Act, hereby makes the following Order:

**PART 1 - GENERAL**

**Commencement and Citation**

1. This Order shall come into operation on the            day of            2024 and may be cited as “The North Norfolk District Council (Off-Street Parking Places) (Variation) (No.1) Order 2024”.
2. Any references to “Variation Order” accordingly relate to “The North Norfolk District Council (Off-Street Parking Places) (Variation) (No.1) Order 2024”.

**Interpretation**

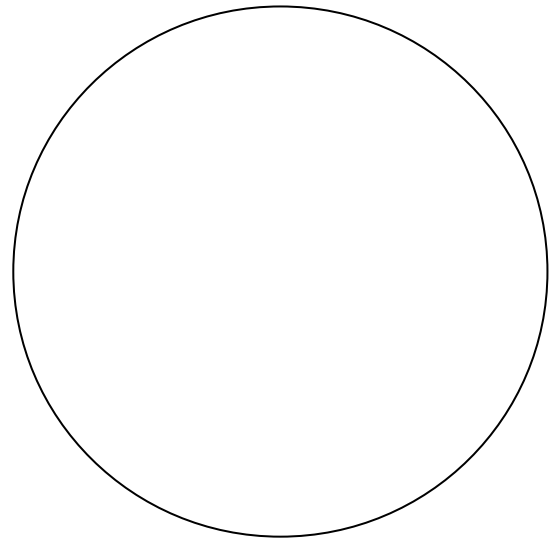
3. In this Variation Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:  
  
**‘the Principal Order’** means the North Norfolk District Council (Off-Street Parking Places) (Consolidation) Order 2024;
4. Except where the context requires otherwise, any reference in this Order to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order;
5. Any reference in this Variation Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted or having effect by virtue of any subsequent enactment.
6. The Interpretation Act 1978 shall apply for the interpretation of this Variation Order as it applies for the interpretation of an Act of Parliament.

**PART 2 - AMENDMENT OF THE PRINCIPAL ORDER**

- 7. The Schedule to the Principal Order shall be amended by deleting the existing charges detailed for the Parking Place identified as 'Holt Country Park Car Park' and replacing with the new charges detailed in the Schedule to this Variation Order.
  
- 8. Save as varied by paragraph 7 of this Variation Order the Principal Order shall continue in full force and effect.
