The Dog Control Orders (Prescribed Offences and Penalties, etc.) Regulations 2006 (S.I. 2006/1059)

The Dogs on Leads, Beaches Order 2007

The North Norfolk District Council hereby makes the following Order:

- 1. This Order comes into force on the 7th May 2007
- 2. This Order applies to the land specified in the Schedule 1

Offence

- (1) A person in charge of a dog shall be guilty of an offence if, during the time period specified in Schedule 2, on any land to which this Order applies he does not keep the dog on a lead of not more than 1.8meters unless –
 - (a) he has a reasonable excuse for failing to do so; or
 - (b) the owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his failing to do so.
 - (2) For the purposes of this article a person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog.

Penalty

4. A person who is guilty of an offence under article 3 shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.

Schedule 1

- 1. This order applies to the land highlighted in yellow on the attached plans, specifically;
 - (i) <u>Sheringham</u> The promenades and access ways adjacent to the beaches between the Lifeboat Shed (National Grid Reference 1528-4353) and the Lifeguard Station (National Grid Reference 1610-4348).
 - (ii) West Runton The roadway from the entrance to the Car Park (National Grid Reference 1850-4312) north easterly to the slipway (National Grid Reference 1858-4318) and then easterly along the promenade walkway to the end thereof (National Grid Reference 1865-4311)
 - (iii) <u>Cromer</u> The promenades and access ways between the Doctor's Steps (National Grid Reference 2241-4216) and the first groyne to the west of the Melbourne Slope (National Grid Reference 2160-4245).
 - (iv) Overstrand The access way from Clifton Way (National Grid Reference 2525-4059) to promenades and access ways between the furthermost east (National Grid Reference 2525-4055) and the furthermost west (National Grid Reference 2482-4105) slipways.
 - (v) <u>Mundesley</u> The promenades and access ways between the foot of the access slope near the Manor Hotel (National Grid Reference 3131-3686) and the Fishermen's Slope (National Grid Reference 3160-3663).
 - (vi) <u>Bacton</u> The promenade walkway and access ways between the second groyne north west of the steps at the end of Beach Road (National Grid Reference 3413-3429) and the second groyne south east of those steps (National Grid Reference 3452-3399).
 - (vii) Walcott The promenade walkway and access ways between the third groyne north west of the slipway (National Grid Reference 3562-3315) to the steps to the south east of the slipway (National Grid Reference 3612-3282).
 - (viii) Sea Palling The access road from Cart Gap (National Grid Reference 4300-2746) south-westwards for a distance of 50 meters (National Grid Reference 4300-2740), and the access way and steps leading to the beach from the track opposite to Beach Cottage (National Grid Reference 4256-2776).

Schedule 2

1. This order applies at any time between the 1st May and the 30th September of any year.
