The Dog Control Orders (Prescribed Offences and Penalties, etc.) Regulations 2006 (S.I. 2006/1059)

The Dogs Exclusion, Beaches Order 2007

The North Norfolk District Council hereby makes the following Order:

- **1.** This Order comes into force on the 7th May 2007.
- 2. This Order applies to the land specified in Schedule 1.

Offence

- **3.** (1) A person in charge of a dog shall be guilty of an offence if, during the periods specified in Schedule, he takes the dog onto, or permits the dog to enter or to remain on, any land to which this Order applies unless—
 - (a) he has a reasonable excuse for doing so; or
 - (b) the owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his doing so.
 - (2) Nothing in this article applies to a person who—
 - (a) is registered as a blind person in a register compiled under section 29 of the National Assistance Act 1948; or
 - (b) is deaf, in respect of a dog trained by Hearing Dogs for Deaf People (registered charity number 293358) and upon which he relies for assistance; or
 - (c) has a disability which affects his mobility, manual dexterity, physical coordination or ability to lift, carry or otherwise move everyday objects, in respect of a dog trained by a prescribed charity and upon which he relies for assistance.
 - (3) For the purposes of this article—
 - (a) a person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog; and
 - (b) each of the following is a "prescribed charity"—
 - (i) Dogs for the Disabled (registered charity number 700454);
 - (ii) Support Dogs (registered charity number 1088281);
 - (iii) Canine Partners for Independence (registered charity number 803680).

Penalty

4. A person who is guilty of an offence under article 3 shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.

Schedule 1

- 1. This order applies to the land shaded in red on the attached plans, specifically;
 - (i) <u>Sheringham</u> Beaches between the groyne next to the Lifeboat Shed (National Grid Reference 1530-4354) and the groyne nearest the Lifeguard Station (National Grid Reference 1610-4348).
 - (ii) West Runton Beaches from the slipway (National Grid Reference 1858-4318) to the easterly end of the promenade walkway (National Grid Reference 1865-4311)
 - (iii) <u>Cromer</u> Beaches between the groyne opposite the Doctor's Steps (National Grid Reference 2241-4216) and the first groyne to the west of the Melbourne Slope (National Grid Reference 2160-4245)
 - (iv) Overstrand Beaches between access from the Clifton Way Access Slope (National Grid Reference 2525-4067) and the groyne nearest the furthermost west slipway (National Grid Reference 2482-4105).
 - (v) <u>Mundesley</u> Beaches between the promenade steps at the western end of the beach (National Grid Reference 3131-3686) and the Fishermans Slope Access (National Grid Reference 3160-3663).
 - (vi) <u>Bacton</u> Beaches between the second groyne north west of the steps the end of Beach Road (National Grid Reference 3413-3429) and the second groyne to the south east of those steps (National Grid Reference 3452-3399).
 - (vii) Walcott Beaches between the third groyne to northwest of the slipway (National Grid Reference 3562-3315) and the steps to the south east of the slipway (National Grid Reference 3612-3282).

(viii) <u>Sea Palling</u> – Beaches from the Cart Gap (National Grid Reference 4300-2746) north-westwards for a distance of approximately 520 meters to the second set of access steps (National Grid Reference 4260-2780)

Schedule 2

1. This order applies at any time between the 1st May and the 30th September of any year.
